#### Location

Wishaw is a popular North Lanarkshire town with a population of some 30,000 and is located at the junction of the A721 and A722, 15 miles south-east of Glasgow city centre. The A71 lies 1 mile to the south-east and the M74 (Junction 7) 6 miles to the south-west. Main Street is situated in the heart of the town centre and is the principal retail thoroughfare.
