



### Location

Prescot is a popular commuter town located approximately 8 miles east of Central Liverpool and close to Junction 2 of the M57. Junction 7 of the M62 is approximately 2 miles to the south.

The property, located within a Conservation Area, is situated within the town centre to the western end of the pedestrianised Eccleston Street, the main retail thoroughfare in the town.

Occupiers close by include HSBC (adjacent), Lloyds TSB, Greggs, Halifax, Thomsons and a range of other retailers and estate agencies.

### Description

The property is arranged on basement, ground and one upper floor to provide a ground floor estate agent's office with ancillary accommodation to the first floor.
