Location

Leeds is the principal commercial, financial and administrative centre for the North of England and serves a population of some 680,000. The city enjoys excellent communications being at the junction of the M1 and M62 Motorways, having regular rail services (London King's Cross, 2 hours) and also benefiting from Leeds/Bradford Airport some 7 miles north of the city centre.

Middleton Park is situated about 3 miles south of Leeds city centre with easy access to the M1, M62 and A653.

The property forms part of the local shopping area and occupiers close by include Greggs, Post Office, Sainsbury's Local, Boots, Betfred and Coral.

Description

The property is arranged on ground and one upper floor to provide a shop unit with ancillary accommodation to the first floor. The shop will shortly interconnect with the adjacent unit (no. 17) which is presently being shop fitted, but does not form part of this lot. 
