Location

Wakefield has a population of approaching 74,000 and is located on the River Calder, 8 miles south of Leeds and 5 miles east of Dewsbury. The town is within 3 miles of both the M1 (Junctions 39, 40 and 41) and M62 (Junction 3) motorways and benefits from regular rail services to destinations throughout the north-east.

The property is situated in a prominent position on the north side of pedestrianised Kirkgate opposite McDonald's and close to the Ridings Shopping Centre.

Other occupiers close by include Marks & Spencer, Boots, Santander, Halifax, Caff  Nero and BHS amongst others.

The property is arranged on ground and two upper floors to provide an attractive period ground floor banking hall with further public banking accommodation on part first floor and additional ancillary accommodation on the remainder of the first and the second floors.

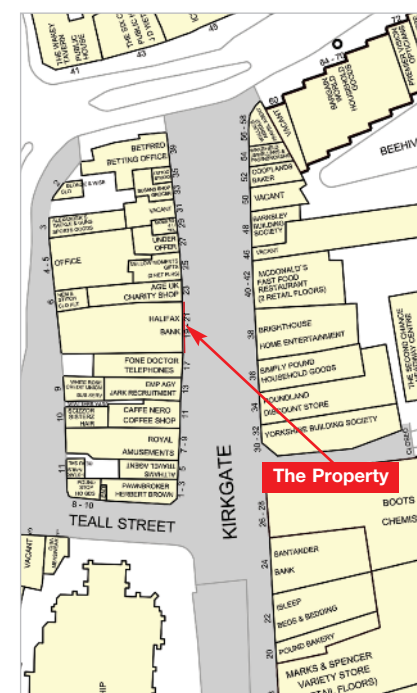
