

Location

Wigan is approximately nine miles south-west of Bolton, 10 miles north of Warrington and 16 miles north-west of Manchester. Wigan Borough has a population of approximately 318,000. The town is well served by transport links, with Ormskirk Road (A577) providing access to Junction 26 of the M6 and the M58 approximately five kilometres (three miles) to the west. The A58 provides a link to Junction 5 of the M61 approximately nine and a half kilometres (six miles) to the east. The property is situated about a mile east of Wigan town centre and is accessed via the A577 Manchester Road. The M6 Motorway is 4 miles to the west and the M61 3 miles to the east.

The surrounding area is a mix of industrial and residential. Part of the site backs on to the Leeds and Liverpool Canal.
