


Location
Swadlincote, located on the A511, is situated 12 miles south-west of Derby and 5 miles south of Burton-on-Trent and serves a wide catchment area. Church Gresley is a village located to the south of Swadlincote. To the east, the A511 provides access to the A42 and on to Junction 11 of the M42 and Junction 23A of the M1. To the west the A444 provides access to Junction 11 of the M42. The property is situated on the south side of Swadlincote and is bounded by John Street and Pool Street.

Description
The site comprises a complex of former pottery manufacturing buildings, originally known as T.G Green Works and Masons Cash Works, which are now largely derelict. With regard to the T.G Green works, permission has been obtained for the demolition of the majority of the buildings whilst safeguarding four bottle kilns which are Listed Grade II* as historic interest, and some associated buildings. We understand that none of the buildings on the Masons Cash Works are Listed.
