



#### Tenure

Leasehold. To be held for a term of 999 years from completion at a fixed peppercorn rent.

#### Location

Ashford is a densely populated London suburb located approximately 19 miles south-west of London, some 1¼ miles west of Staines. The area benefits from good communications, with road access to the M25 motorway (Junction 13) 2½ miles to the west via the A30.

Heathrow Airport is also a short distance to the north.

The property is situated in a parade of shops in the centre of Ashford close to a post office, Lloyds Pharmacy, Co-Operative Food, Boots Pharmacy and Ladbrokes.

#### Description

The property is arranged on ground floor only to provide a retail unit with ancillary accommodation to the rear. There is also a mezzanine floor which is used for storage. The property forms part of a larger building, the remainder of which is not included in the sale.

#### Tenancy

The property is at present let to GERRYS OFFSHORE INCORPORATIONS LIMITED (t/a Costa Coffee) for a term of 15 years from 25th October 2013 at an initial rent of  $\pounds$ 19,000 per annum. The lease provides for rent reviews every fifth year of the term and contains effectively full repairing and insuring covenants.

(1) There is a lessee's option to determine at the end of the sixth and eleventh years.

(2) There is a rent free period expiring 24th August 2014. The seller will 'top-up' the rent by way of reduction to the purchase price so the buyer effectively receives £19,000 per annum from completion until expiry of the rent free period.
