

Location

Blyth is located on the north-east coast of Northumberland just to the south of the River Blyth and has a population of approximately 36,000. The town lies approximately 15 miles north of Newcastle upon Tyne and 3 miles east of the A189.

The property is situated on the eastern side of the pedestrianised part of Regent Street adjacent to the entrance into the Keel Row Shopping Centre, where occupiers include New Look, Bon Marché, Superdrug, Dorothy Perkins and Store Twenty One.

Other occupiers close by include Iceland, Boots, Burton, Halifax and Lloyds TSB.

The property is arranged on ground and one upper floor to provide a prominent ground floor corner shop unit together with self-contained first floor offices above which are separately accessed off Regent Street.
