

Cheadle Hulme is a suburban area, located some 8 miles south of Manchester city centre and 5 miles north of Wilmslow. More particularly, the town is located east of the A34 which provides access to the M54 and M60 motorways.

The property fronts Turves Road and is situated in a well established parade in a predominantly residential area, approximately half a mile west of Cheadle Hulme town centre. Occupiers close by include a range of local traders together with McColls, Domino's Pizza, and Co-op Convenience Store

The property is arranged on ground and one upper floor to provide a shop with self-contained flat above. The flat is presently used for ancillary storage and is accessed from the rear.
