#### Location

Leicester is one of the East Midlands major commercial centres, located adjacent to the M1 and M69 motorways. The city has a population of some 318,000 and has regular rail services to London and the north.

The property is situated on the south side of Silver Street close to St Martins Square Shopping Centre. Silver Street is a very busy pedestrianised retail thoroughfare in the city centre and occupiers close by include a large O'Neills Pub, Prezzo, BHF, Game, Coral and a wide range of retailers, pubs and restaurants.

#### Description

This attractive Grade II Listed property is arranged on basement, ground and two upper floors to provide a restaurant fitted out in Ask's corporate style with dining areas on ground and first floor levels. The open kitchen is on the ground floor along with a preparation area and storage. The basement provides storage and the second floor provides staff accommodation. Customer WCs are on the first and second floors. There is an attractive external seating area at the rear with access from Silver Street and from The St Martins Shopping Centre.
