The property is situated on the east side of Clarence Road, to the south of its junction with Upper Street. Clarence Road is predominantly occupied by residential houses and flats. Local shops and facilities are readily available in Fleet town centre, with the more extensive facilities of Farnborough lying to the east and Basingstoke to the west. Road access is provided by the nearby M3 Motorway to the north and Fleet Rail Station is to the north-east.
