Location

Lewisham is a densely populated South-East London suburb and an important retail centre located 4 miles south-east of Central London. The property enjoys good rail connections to London and the South-East whilst road communications are good with the A20 and A21 trunk roads passing close by.

The property is situated on the west side of Lewisham High Street (A20) close to an entrance to Lewisham Shopping Centre. Lewisham High Street becomes pedestrianised a short distance to the south. Lewisham Rail Station lies a short distance to the north-west and provides both Docklands Light Railway and National Rail services towards Central London and the Docklands.

Occupiers close by include Chelsea Building Society, HBOS (Halifax), Ladbrokes, Boots, Paddy Power, Vodafone and Barclays Bank amongst others.
