Tenure

Leasehold. The property is held on a lease for a term of 125 years from 25th March 2014 (thus having approximately 123 years unexpired) at an initial ground rent of £200 per annum.

Location

The property is located on the north side of Gunterstone Road, between its junction with Gwendwr Road and Trevanion Road. Local shops and amenities can be found along the nearby North End Road, with further facilities being available in nearby Hammersmith to the west. Kensington High Street and Kensington Olympia are to the north. There are a number of restaurants, bars and boutique shops in Brook Green, with a more extensive range of national retailers available along Kensington High Street and at the Westfield Centre, the largest covered shopping centre in London. The A4 is easily accessible and provides access to the M4 Motorway to the west and Central London to the east. Barons Court and West Kensington Underground Stations are both within walking distance. Holland Park is to the north-east offering green open spaces.
