The village of Coundon is approximately two miles to the west, offering some local shops and St Joseph's Primary School. The more extensive facilities of Bishop Auckland are available further to the west, providing a variety of shops, Bishop Auckland College, Bishop Auckland Hospital and Bishop Auckland Rail Station. The A1 Motorway is accessible 3.6 miles to the east.

The property comprises a Grade II listed former manor house arranged over ground, first and second floors. The building occupies a site extending to approximately 0.976 hectares (2.411 acres). 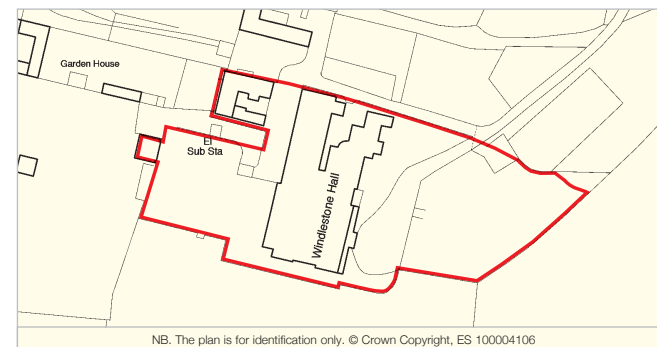
