

Location

The property is situated on the north-east side of Milton Crescent, to the south of its junction with Calver Hey Road in the Beaumont Leys district of Leicester. The Beaumont Shopping Centre, home to Matalan, Tesco Extra, Argos, Superdrug, Subway and McDonald's, amongst other national retailers, is close by. A further range of shops and local amenities is accessible in Leicester city centre approximately 2 miles to the south-east. Leicester Rail Station provides regular and direct services into London, Sheffield, Nottingham, Derby and Birmingham amongst other destinations and both the M1 and M69 Motorways are within reach. Glenfield Hospital is approximately 1 mile to the west and East Midlands Airport is within reach to the north-west.

Description

The property comprises an unbroken purpose built block of flats arranged over ground and six upper floors. The property has recently

undergone a programme of comprehensive refurbishment and is internally arranged to provide a total of 33 self-contained flats. In addition, there is a storage area on the ground floor which is to be offered with planning permission for change of use to provide an additional two flats. The building benefits from a passenger lift which serves all floors and an intercom system (not tested). The building occupies a site which extends to approximately 0.11 hectares (0.28 acres) and additionally provides off-street parking for approximately 12 cars and communal garden areas.
