Location

Taunton, the county town of Somerset, is an affluent centre with a resident population of some 55,000, lying between Bristol and Exeter. Road communications are excellent with the M5 (Junction 25) within 2 miles of the town centre accessed via the A358. In addition there are regular rail services to Exeter/Plymouth, Bristol and London. The property is situated in a busy trading position at the junction of Fore Street and Hammet Street in the heart of the town centre. Tenancy
