#### Location

Farnham is an attractive and prosperous town with a district population of some 115,600. The town is situated on the Hampshire-Surrey border, 10 miles west of Guildford and some 40 miles south-west of Central London. The town is served by the A31 dual carriageway which links with the A3 at Guildford whilst Junction 4A of the M3 motorway is 7 miles to the north. The property is situated on The Borough, which is the main town centre shopping street, at its junction with South Street in a prominent corner position.

Occupiers close by include Santander, Clinton Cards, Moss Menswear, W H Smith, Dorothy Perkins, Boots Opticians and Peacocks. Sainsbury's and a multi-storey car park are nearby on South Street. There is a proposed town centre redevelopment by Crest Nicolson and Sainsbury's a short distance away on East Street which will revitalise the town centre.

#### Description

The property is arranged on basement, ground and two upper floors to provide a ground floor banking hall with office and staff accommodation on the upper floors and storage in the basement. The ground floor banking hall was fully refurbished in 2011 including the installation of a 6-person passenger lift. The lock-up ground floor shop unit is also on The Borough adjacent to the Bank.
