#### Location

Swindon is a major Thames Valley commercial town some 70 miles west of London with a population of some 180,000. Swindon is situated between Junctions 15 and 16 of the M4 motorway and is served by regular rail services to London and the south-west. Oxford is some 25 miles to the north-east. Major employers in Swindon include Honda, Nationwide Building Society, Zurich Financial Services, National Power and the National Trust.

The Co-Op Supermarket is situated at the junction of High Street and Newport Street within the Old Town area of Swindon town centre. The subject property has frontages to both Newport Street and Hoopers Place at the rear.

Occupiers close by include HSBC together with a number of restaurants and leisure occupiers.

#### Description

The property forms part of a larger property, not included in the sale, being a large supermarket occupied by the Co-Op. The property comprises part of this supermarket, being the main entrance from the car park, the Co-Op Travel Store together with part of the parking provision at the rear of the property.
